The Parent Teacher Organization (PTO) executive board was consulted August 5, 2020 during an in-person meeting. They were supportive of moving forward with the waiver application process. Our finance committee and Father Angelos, our lead pastor who represents our four parish communities, were also consulted. A State of the School Reopening Plan webinar was presented August 6, 2020 to all parents and staff. Parent survey results attached.

A reopening committee of administrators, staff, and parents was formed to design a reopening plan that includes contingency plans.

Ongoing professional development for all staff in health and safety protocols is planned. A voluntary staff meeting via Zoom was held 8/11/2020. The agenda included plans for students instructional delivery, in-person instruction, and distance learning.






# Q1 I am in favor of our school applying for the waiver which will allow for in-person instruction.
